READ CAREFULLY! Renter has read this agreement and understands and agrees to the following:

1. To pay SR Express Jet Ski & ATV Rentals for the charter of said vessel at the posted rate. Reservation deposits are non-refundable.
2. Renter agrees to read carefully and have all participants sign a release of liability waiver and rules and regulations. All of these documents are hereby incorporated into this contract by this reference.
3. It is the renter's responsibility to inspect and note any damages, or missing equipment, to the ATV BEFORE TAKING.
4. The ATV must be returned in the same condition as received and as noted in the pre-boarding inspection.
5. Each ATV will be inspected by both parties before and after each rental to determine condition of the ATV.
6. All riders/passengers must wear a helmet, goggles and gloves at all times while on the ATV. Maintain a lookout in ALL directions at ALL times. Renter and anyone else caused to have possession as a result of renter's actions will be responsible for any monetary fine assessed by any governmental entity as a result of not wearing a helmet or any other type of infraction.
7. All persons renting equipment must be 21 years of age. SR Express Jet Ski & ATV Rentals does not authorize any renter to allow anyone under the age of 21 to operate the ATV. Should this happen, SR Express Jet Ski & ATV Rentals is not liable for any harm caused to the minor or to any third parties by the minor. Further, SR Express Jet Ski & ATV Rentals is not liable to any government entity for any fine or ticket associated with any such unauthorized operation. Further, any operator of the ATV must sign this contract, otherwise they do not have the permission of SR Express Jet Ski & ATV Rentals to operate the ATV. SR Express Jet Ski & ATV Rentals hereby disclaims any liability resulting to any party not in privity of contract with SR Express Jet Ski & ATV Rentals.
8. If you run out of gas within the boundaries and we have to service you, there will be a minimum charge of \$200.00 plus fuel costs.
9. I agree not to exceed posted weight and passenger capacities for each ATV. See rental rate display.
10. If you have an equipment malfunction or any problem with the ATV, return IMMEDIATELY.
11. There are NO REFUNDS, RAIN CHECKS OR CREDIT FOR UNUSED TIME.
12. Prior to renting the ATV from SR Express Jet Ski & ATV Rentals, renter must take an OHV Riding Class test. The test can be taken at AZgFd.gov. The OHV card must be shown to a representative of SR Express Jet Ski & ATV Rentals prior to renting the ATV.

I have read the RULES, REGULATIONS AND INSTRUCTIONS and agree not to ride the ATV until I feel that I have been fully instructed in the operating and features. I further understand that I am responsible for ANY AND ALL EQUIPMENT AND RETURN OF RENTAL. SECURITY DEPOSIT is required and will be applied to any charges and damages to the ATV up to the full value of the ATV.

I am aware and agree to the following partial schedule of damage repair charges and late fees:

Security deposit of \$500 will be returned provided there are no outstanding charges and the ATV is returned at the scheduled time and place.

I have read, understand and agree to all items. I authorize my credit card to be charged for any and all damages (including theft) to the ATV during the rental or until I return and check in the ATV.

JURISDICTION: In the event a dispute arises regarding this contract, it shall be litigated in Mohave County, Arizona.

INTEGRATION CLAUSE: By signing this contract, I (we) agree this is the entire agreement between the parties. There are no oral representations made that would add additional terms or modify this contract in any way. This agreement shall be interpreted solely between its four corners. The invalidity under Arizona Law of any of its subparts shall not invalidate the entire contract, but rather it would be read to exclude the invalid portion. No agreements prior to the signing of this contract have been made regarding the ATV rental. Finally, any modification to this contract must be in writing and signed by both the renter and SR Express Jet Ski & ATV Rentals.

RENTER IS RESPONSIBLE FOR ANY INJURY OR DEATH THAT MAY OCCUR WHILE RENTING ATV FROM SR EXPRESS JET SKI & ATV RENTALS.
